## Notification of Change of Terminal Handling Charge

Please be informed that there will be some changes in the Terminal Handling Charges for Asiana Cargo (Prefix 988, Code OZ), effective from **1<sup>st</sup> Jan 2012**.

Please note that the below THC changes are a direct result of Menzies' rate increase.

### < Terminal Handling Charge >

#### ASIANA Export Terminal Handling Charges (UK) / (Effective 01 JAN 2012)

##### 1. Standard Charges for Processing and Handling All Cargo : **No changes**

- a) Loose Per kilo 7.0 p Minimum **£20.00**  
Unitised Rate **£20.00 per AKE, £40.00 per Pallet**
- b) Re-build or re-contour shipper built ULDs **£99.00**
- c) In cases of un-declared Dangerous goods an administration fee will apply **£200.00**

##### 2. Security Charges (All cargo/mail including transhipments)

###### Primary screening (Including x-ray, hand-search etc)

- a) Initial Primary screening method per consignment **Per kilo 11.00p Min £14.00**
- b) Additional Primary screening method per consignment **Per kilo 5.5p Min £7.00**

###### Secondary screening (Including Rest)

- a) REST Security Screening (standard service) **Per kilo 26p Min £80.00**
- b) DECOMPRESSION  
Use of decompression chamber CEU **£60.00 + Per kilo 6p**  
Transportation to/from CEU(LHR) MIN **£190.00, per hour £50.00**

- a) DGR check (per air waybill) up to 3 UN numbers/lines **£37.00**
- b) For each UN number/line over 3 **£1.20**
- c) In addition, charge per piece over 10 pieces **£1.20**
- d) Re-check (plus additional charges) **£37.00**
- e) Dry Ice / Radac in excepted packages / DGR in excepted quantities **£18.50**

### Terms and Conditions General

- i) *Charges are calculated based on chargeable weight of the consignment*
- ii) *Charges are minimum rates and may be increased if additional work or expense involved*
- iii) *The tariff is subject to alteration without notice*
- iv) *Other services and charges available on request*
- v) *A 2% charge will apply on credit card payments*

### Exports

- i) *Security charges will apply to SPX/SCO cargo if DfT requirements are not met.*
- ii) *For shipments which are part x-rayed and part RESTed, the applicable charges will apply for each part*
  - iii) *Express service REST charges available on request.*
  - iv) *AWB amendments made at the request of Shipper, Agent or Carrier and/or following an irregularity found by the Carrier or his Agent.*
  - v) *For shipments of personal effects containing undeclared Dangerous goods, the shipment will need to be re-collected for said items to be removed before being re-presented for security recheck. This will be subject to the charges specified in the traffic including handling undeclared Dangerous goods fee and x-ray screening fee on both initial and re-presentation.*
- vi) *Security Handling shipments delivery restricted to within 24 hours of flight departure.*
- vii) *Transport to Decompression subject to Carrier/Agent having authorisation to use the Decompression Chamber*
  - viii) *Shipments requested to be removed from this facility after acceptance, will be subject to all applicable THC's*
- ix) *All security charges may be subject to change*
