ASIANA Export Terminal Handling Charges (UK) / (Effective 01 January 2014)

1. Standard Charges for Processing and Handling All Cargo:

- a) LOOSE **9p** per kilo, Minimum **£20.00**
- Unitised Rate: **£25.00**per AKE, **£49.50**per Pallet.

- b) Re-build or re-contour shipper built ULDs **£105.00**

2. Security Charges (All cargo/mail including trans-shipments)

Primary screening (Including but not limited to x-ray, hand-search etc)

- a) Initial Primary screening method per consignment: **11.5p** p/k, Min **£14.40**
- b) Additional Primary screening method per consignment **5.5p** p/k, Min **£7.00**

Secondary screening (Including but not limited to REST)

- a) Per Secondary screening method (standard service) **13p** p/k, Min **£80.00**
Secondary screening charges apply in addition to the primary security screening charges

b) REST preparation (in-addition to screening charge and including wrapping) **2p** p/k

3. Amendment of an Air Waybill

- a) Miscellaneous Air Waybill corrections **£15.00**
- b) Corrections to declared weights and volumes **£40.00**

4. Standard Charge for Dangerous Goods

- a) DGR check (per air waybill) up to 3 UN numbers/lines **£40.00**
- b) For each UN number/line over 3 **£1.25**
- c) In addition, charge per piece over 10 pieces **£1.25**
- d) Re-check (plus additional charges) **£40.00**
- e) Dry Ice / Radac in excepted packages (RRE), DGR in excepted quantities (REQ), Lithium batteries (ELI/ELM) and (MAG) **£24.00**
- f) In-cases of un-declared Dangerous goods an administration fee will apply **£200.00**

General

- i) Charges are calculated based on chargeable weight of the consignment*
- ii) Charges are minimum rates and may be increased if additional work or expense involved*
- iii) The tariff is subject to alteration without notice*
- iv) Other services and charges available on request*
- v) A 2% charge will apply on credit card payments*
- vi) Any shipment withdrawn after acceptance and processing will be subject to full handling charges*

Exports

- i) Security charges will apply to SPX/SCO cargo if DFT requirements are not met*
- ii) Any shipment of Section 1 or 2 firearms/ammunition not declared as such on the air waybill will be treated as Section 5 and escort fees will apply*
- iii) Express service REST charges available on request*
- iv) For shipments containing undeclared Dangerous goods, the shipment will need to be re-collected for said items to be removed before being re-presented for security re-check. This will be subject to the charges specified in the tariff including handling undeclared Dangerous goods fee and x-ray screening fee on both initial and re-presentation*
- v) AWB amendments made at the request of Shipper, Agent or Carrier and/or following an irregularity found by the Carrier or his Agent*
- vi) Security handling shipments delivery restricted to within 24 hours of flight departure*
- vii) Shipments requested to be removed from this facility after acceptance, will be subject to all applicable THC's including minimums.*
